

# **Definitions for IDPH Data Collection Report**

## **1) Patients Presented (All hospitals):**

The total number of patients that presented to your emergency room, were treated in your emergency room or were treated by your emergency room staff for sexual assault or sexual abuse. This number should include:

- Any patient that meets the current minimum requirements for an Illinois State Police Sexual Assault Evidence Collection Kit (ISP SAECK):
  - Present with a complaint of sexual assault/abuse within a **minimum** of the last 7 days
  - Or
  - Who have disclosed past sexual assault/abuse by a specific individual and were in the care of that individual within a **minimum** of the last 7 days
- Any patient presenting beyond the timeframe to perform for an (ISP SAECK) (NOTE: the kit **can** be offered well beyond 7 days for certain patient populations)
- Any patient that was received as a transfer from another facility as part of an area wide treatment plan
- Any patient that was treated on an in-patient unit by your emergency room staff

## **2) Kits Offered All (All hospitals):**

The total number of patients that were offered an ISP SAECK. This number may or may not match the number in “patients presented” above due to patients who present with a delayed disclosure (i.e. months or years after a sexual assault/abuse).

## **3) Kits Completed All (All hospitals):**

The total number of patients for which consent was obtained and an ISP SAECK was completed. (Note: a patient may decline any portion of the kit collection, but if **any evidence** is collected than that would count as being completed, including underwear/clothing or urine samples).

## **4) Kits Declined Collection All (All hospitals):**

The total number of patients for which the opportunity to consent was offered and collection of an ISP SAECK was declined. (Note: a copy of the consent form with declination signatures should be available in the patient’s medical record).

## **5) # Pediatrics Presented (All hospitals):**

The total number of patients **under the age of 13** that presented to your emergency room, were treated in your emergency room or were treated by your emergency room staff for sexual assault or sexual abuse.

This number should include:

- Any patient that meets the current minimum requirements for an Illinois State Police Sexual Assault Evidence Collection Kit (ISP SAECK):
  - Present with a complaint of sexual assault/abuse within a **minimum** of the last 7 days
  - Or
  - Who have disclosed past sexual assault/abuse by a specific individual and were in the care of that individual within a **minimum** of the last 7 days
- Any patient presenting beyond the timeframe to perform for an (ISP SAECK)
- Any patient that was received as a transfer from another facility as part of an area wide treatment plan
- Any patient that was treated on an in-patient unit by your emergency room staff

**6) # Pediatric Accepted for Transfer (Treatment with APT only):**

The total number of patients **under the age of 13** that were transferred from your emergency room to a treatment hospital or approved pediatric health care facility as part of an area wide treatment plan.

**7) Kits Offered to Pediatric (Treatment Hospital only):**

The total number of patients **under the age of 13** that were offered an ISP SAECK. Remember that the definition for when to offer a kit was expanded in 2019 to include those who have disclosed past sexual assault/abuse by a specific individual and were in the care of that individual within a **minimum** of the last 7 days.

**8) Kits Completed for Pediatric (Treatment Hospital only):**

The total number of patients **under the age of 13** for which consent was obtained and an ISP SAECK was completed. (Note: a patient/parent/guardian may decline any portion of the kit collection, but if any evidence is collected than that would count as being completed).

**9) Kits Declined for Pediatric (Treatment Hospital only):**

The total number of patients **under the age of 13** for which the opportunity to consent was offered and collection of an ISP SAECK was declined. (Note: a copy of the consent form with declination signatures should be available in the patient's medical record).

**10 Patients received from a Treatment Hospital with APT, Transfer Hospital or APHCF**

The total number of patients that were received by your emergency room as a transfer from another facility or approved pediatric healthcare facility as part of an area wide treatment plan.

**11) Out of State referrals from police/other**

The total number of patients that were received by your emergency room after being referred from law enforcement, an Illinois hospital, rape crisis center, walk-ins or other entity that were not initially transferred from an Illinois hospital.
