SUBJECT: Update on Pfizer/BioNTech COVID-19 Vaccine

On Friday and Saturday, the U.S. Food and Drug Administration (FDA) and Centers for Disease Control and Prevention (CDC) approved the recommendations of their key advisory committees on an Emergency Use Authorization and the initial priority allocation of the Pfizer BioNTech COVID-19 vaccine. On Sunday, Pfizer began distributing the vaccine to states across the country, including Illinois. The FDA, CDC, Illinois Department of Public Health (IDPH) and Chicago Department of Public Health (CDPH) have issued numerous guidance documents and other information over the weekend. IHA wants to ensure you are aware of the distributed materials.

#### IDPH

IDPH is responsible for overseeing the distribution and allocation of the vaccine in EMS Regions 1-10 outside the city of Chicago, while CDPH is responsible for EMS Region 11/Chicago.

On Friday, IDPH held a webinar, specifically for hospitals, on the state's mass vaccination plan and answered questions from hospital staff. Following is a link to a one hour recording of that webinar and some answers provided by IDPH to some key questions that arose during the webinar.

IDPH written answers to select webinar questions:

- "EMS is included in Phase 1a, however, week 1 allocation in Illinois is for hospitals. Can
  hospitals vaccinate EMS as part of the first week's allocation?" Yes. The allocation must go to
  the hospital and the vaccine be administered in a hospital setting. EMS staff <u>are</u> eligible to be
  vaccinated in the first week's allocation, subject to availability of doses and sub-prioritization
  within the facility.
- 2. "Can Pfizer vaccine be kept in a vaccine freezer?" No. The Pfizer vaccine can only be kept in: 1. Ultra-Cold Freezer (-80c to -60c) for up to 6 months, 2. Pfizer Ultra Cold Shipper "Thermal Shipper" (-90c to -60C) for up to 30 days, being refilled with dry ice every 5 days, 3. Refrigerated at 2c to 8c, for up to 120 hours or 5 days.
- 3. "If we have vaccine that will be wasted, but we have no more staff in Phase 1a, can we give it to the next priority population in order not to waste vaccine?" It is important when you receive your allocation, that you are certain you can utilize it within the time frame. You should also be planning now and identifying staff to be vaccinated. However, if you end up with more vaccine than the phase you are currently in, in order not to waste the vaccine, you can vaccinate people in the next phase. It is extremely important not to waste any doses of vaccine. Please make sure to plan ahead to identify all those who will be receiving vaccine ahead of time to ensure you are covering your Phase 1a population. If you vaccinate individuals in the next phase, please ensure you notify your ERC.

### CDPH

CDPH issued an alert on its Health Alert Network (HAN). The alert included the following key information and action items:

## **Summary and Action Items**

- CDPH expects to receive a limited supply of vaccine within the next 1-2 weeks.
- Over the next 2 weeks, distribution will occur to hospitals with capacity for ultra-cold storage, and local pharmacies federally contracted to vaccinate long-term care facility residents and staff.
- Ensure that your healthcare system vaccine liaisons are on-call to receive vaccine as well as updated resources over time. Check <a href="https://www.chicagohan.org/covidvax">www.chicagohan.org/covidvax</a> for updates.
- CDPH summarized considerations for sub-prioritization of healthcare personnel based on risk of exposure and risk of severe COVID-19 disease in a <u>Health Alert released November 25, 2020</u>.

#### CDC COCA Call on COVID-19 Vaccine Safety

The Centers for Disease Control and Prevention will hold a Clinician Outreach and Communication Activity (COCA) Call, "What Every Clinician Should Know about COVID-19 Vaccine Safety", on Monday, December 14 at 12 p.m. CT.

During this call, clinicians will learn how they can educate their patients on what to expect after COVID-19 vaccination. In addition, they will learn how they can play an important role in monitoring the safety of COVID-19 vaccines, including encouraging patients to enroll in v-safe - a new smartphone-based, after-vaccination health checker for people who receive COVID-19 vaccines - and to use v-safe to report how they're feeling. Clinicians also will learn how to report adverse events (possible side effects) to the Vaccine Adverse Event Reporting System (VAERS).
