RE: Cycle 08 Antibody Therapy Allocations to Healthcare Partners

Cycle 08 Antibody therapy were allocated the week of 11/01 to 11/07/2021 as below. It includes three monoclonal antibody preparations for outpatient management of Covid-19:

- a) Regeneron's antibody cocktail casirivimab/imdevimab (IV or SubQ for treatment or post exposure prophylaxis)
- b) Bamlamnivimab/etesivimab (IV only for treatment or post exposure prophylaxis)
- c) Sotrovimab (IV only for treatment).

In Cycle 08 the State of Illinois was allocated 1010 patient courses of bamlamnivimab/etesivimab and 1680 patient courses of Regeneron's casirivimab/imdevimab and 672 patient courses of Sotrovimab.

State Allocation Process will consider the following metrics:

- Prior utilization per teletracking and NHSN reports
- Case rate by county
- Available ICU beds in COVID Region (not all counties have ICU beds)
- Social Vulnerability Index by county (High vs. Low SVI)

Updates:

- Please consider using bamlanivimab/etesevimab IV in place of regencov IV for infusions in situations of shortage.
- IV Regeneron formulations may also be used for Subcutaneous dosing.
- The week of Cycle 10 please request your Cycle 11 allocation as well due to the Thanksgiving Holiday.

Any vials not accepted by healthcare partners will be re-allocated to other healthcare providers based on urgent requests to IDPH. Note: A request does not guarantee the amount of Mab requested will be provided or that the request will be approved. Priority will be based on areas of the state with the greatest need.
