Illinois Hospital Leaders to Showcase Quality Improvement Initiatives at the State Capitol

4th Annual IHA Quality Advocacy Showcase on April 3 Highlights Statewide Efforts to Advance Patient Care, Improve Communities and Reduce Costs

Springfield, Ill.—Hospital leaders from 90 Illinois Health and Hospital Association (IHA) member hospitals and health systems gathered in the State Capitol on April 3 to share with legislators their work to address critical healthcare issues—from opioid overuse and social determinants of health to infection prevention and behavioral health.

Each participating hospital and health system displayed a 30-by-42-inch poster describing their efforts and how the initiative has benefited patients, families and communities while reducing healthcare costs.

The 2019 IHA Quality Advocacy Showcase took place in the Capitol’s first-floor rotunda and two adjoining hallways between 11 a.m. and 2 p.m. The event represents the collective efforts of Illinois’ hospital community to advance quality care and achieve cost savings in the following categories:

- Behavioral Healthcare;
- Care Coordination;
- Infection Prevention;
- Opioid Stewardship;
- Patient Safety;
- Social Determinants of Health; and
- Workplace Safety.

The showcase, in its fourth year, visually demonstrates the work of physicians, nurses, quality improvement leaders and hospital administrators to develop and implement solutions to improve care. See below for a complete list of participating hospitals and health systems.

The gallery of posters for the 2019 event spanned a wide variety of quality improvement and patient safety initiatives, including efforts to:

- Promote safe opioid prescribing to reduce opioid overuse;
- Increase access to behavioral health services and decrease transfer wait times;
- De-escalate and manage aggressive/violent patients to enhance workplace safety;

- Reduce healthcare-associated infections, avoidable readmissions and unnecessary emergency department visits;
- Improve outcomes for patients after total joint replacements and other surgeries; and
- Provide dental health services, reduce food insecurity and address housing issues that negatively impact health.

“The Showcase gives hospital leaders and frontline staff an important opportunity to share their efforts to advance quality care,” said IHA President and CEO A.J. Wilhelmi. “It’s essential that policymakers and elected officials see how Illinois hospitals are doing more to serve their patients and communities—through innovation and practical strategies that improve outcomes.”
