Illinois Hospital and Health Systems Showcase Quality Improvement Initiatives

5th Annual IHA Quality Advocacy Showcase Highlights Statewide Efforts to Advance Patient Care, Improve Communities and Reduce Costs

Naperville, III.—Eighty quality improvement projects from hospitals and health systems across the state represent the dedicated efforts of healthcare professionals to advance quality care and enhance health and well-being for patients and communities. The projects are part of the Illinois Health and Hospital Association (IHA) Quality Advocacy Showcase, held virtually this year due to the COVID-19 pandemic.

Instead of gathering in the State Capitol in April as originally planned, hospital and health system leaders are virtually sharing their work to address critical healthcare issues—from opioid overuse and community health to infection prevention and behavioral health—with legislators.

A compendium of the 80 projects is available <u>online</u>. Participating hospitals and health systems described their project and how it benefits patients, families and communities while reducing healthcare costs.

The Showcase highlights the collective efforts of Illinois' hospital community to advance quality care and achieve cost savings in the following categories:

- Behavioral Healthcare;
- Care Coordination;
- Community Health
- Emergency Preparedness
- Infection Prevention;
- Opioid Stewardship; and
- Patient Safety.

The showcase, in its fifth year, visually demonstrates the work of physicians, nurses, quality improvement leaders and hospital administrators to develop and implement solutions to improve care. See below for a complete list of participating hospitals and health systems.

2020 Showcase projects are diverse mix of quality improvement and patient safety initiatives, including efforts to:

- Reduce opioid use for postoperative pain management;
- Provide early treatment for youth displaying their first psychotic symptoms;
- Improve care for technology-dependent children in their home;
- Address housing insecurity for high-use patients;
- Improve access to immunization services; and
- Empower staff to respond to an active threat incident.

"The COVID-19 pandemic reminds us of the tremendous role of Illinois hospitals and frontline staff in serving communities," said IHA President and CEO A.J. Wilhelmi, "but we know their dedication to patients is just as strong during 'normal' times. Their work to deliver better care is so important. IHA's annual Quality Advocacy Showcase communicates to policymakers and elected officials that Illinois hospitals are dedicating time and resources to achieve positive results for patients, families and communities."
