## FY 2021 MEDICARE HOSPICE PROSPECTIVE PAYMENT SYSTEM – RATE UPDATE CMS-1733-F

On Aug. 4, the Centers for Medicare & Medicaid Services (CMS) published its annual <u>final rule</u> updating the Medicare Hospice Prospective Payment System (PPS) wage index, payment rates, and quality-reporting program effective Oct. 1, 2020 through Sept. 30, 2021. CMS estimates an **increase** in Medicare payments for U.S. hospices of approximately 2.4% or \$540 million compared with federal fiscal year (FFY) 2020.

Final Market Basket Update (*Federal Register (FR) pp. 47083-47086*): The overall rate change includes a 2.4% inpatient hospital market basket increase and the Affordable Care Act (ACA)-mandated productivity adjustment reduction of 0.0 percentage points. The hospice cap amount for FFY 2021 is \$30,683.93 compared to the FFY 2020 cap amount of \$29,964.78. The final labor and non-labor portions for FFY 2021 are:

FFY 2021 Final Election Statement (FR p. 47086): CMS finalized modifications to the hospice election statement requirements to provide an addendum effective FFY 2021. In addition, CMS finalized a policy that requires the signed addendum or any signed update as a new condition for payment. The addendum must list the items, services and drugs that are unrelated to the terminal illness and related conditions.

FFY 2021 Final Quality Reporting Program (QRP) (FR pp. 47083-47084): There are no changes or updates to the Hospice QRP for FFY 2021. Since FFY 2014, the ACA requires hospices to collect and submit quality data, and there is a 2% penalty if hospices do not comply.

FFY 2021 Final Wage Index (*FR pp. 47073-47074*): CMS finalized adoption of the CBSA delineations published in the September 2018 Office of Management and Budget (OMB) <u>Bulletin No. 18-04</u>. This reassigns or alters some counties, which may affect the wage index for some providers. In an effort to alleviate significant losses in revenue, CMS adopted a two-year

transition period including a 5% cap on the reduction of a provider's wage index for FFY 2021 compared to its wage index for FFY 2020. The full reduction (if applicable) will be implemented for FFY 2022.
