MAPS PSO Releases White Paper on Top 10 Patient Safety Issues for 2020

Naperville, III.—The Midwest Alliance for Patient Safety (MAPS) Patient Safety Organization (PSO) has released *Patient Safety Focus: Top 10 Safety Issues for 2020*, a white paper offering strategies to address some of healthcare's top challenges. The white paper was provided to MAPS members as part of their membership, but it is also available for non-members to purchase.

"As a certified Patient Safety Organization, MAPS is committed to guiding healthcare organizations in improving care across the Midwest," said MAPS President Helga Brake, PharmD, CPHQ, CPPS. "By sharing insights, resources and strategies, we can strengthen the patient safety efforts of healthcare organizations and our MAPS PSO community to benefit patients and families."

The white paper includes evidence-based recommendations on the following topics:

- 1. Care transition handoffs;
- 2. Clostridioides difficile infections;
- 3. Discharge against medical advice;
- 4. Emergency department boarding of behavioral health patients;
- 5. Maternal opioid use;
- 6. Medical device-related pressure injuries;
- 7. Patient and family engagement;
- 8. Post-error support for clinicians;
- 9. Social determinants of health screening; and
- 10. Workplace violence de-escalation.

"To develop this white paper, we integrated information from the MAPS event reporting database, as well as our staff's research and analysis," said MAPS Senior Director Carrie Pinasco. "Learnings from the PSO community make it a truly collaborative and thorough resource."
